With reference to the above mentioned subject I have been instructed state that the state government has no objection to issue No objection certificate to Mount St. Mary's Convent College, Lalpur for seeking affiliation from C.B.S.E New Delhi with the following restrictions.

1.


A. For seeking affiliation to the council for the Indian School certificate examination/C.B.S.E./Bharatiya Shiksha Board the educational institution situated in Uttarakhand will have to comply with the conditions/norms laid down by the aforesaid board.

B. The registered society of the school must be renewed from time to time.

C. There will be a member nominated by the Director of Education in the management committee of the school.

D. At least 10 percent of the seats in the school would be reserved for meritorious students of the scheduled castes/scheduled tribes and the fees charged from them would not be more than the prescribed fees charged in various classes of the schools.

E. The Institute will not demand for any grant from the state Government and if the school had recognition from the Uttarakhand school Education Board previously and gets affiliated to council for the Indian school certificate Examination/Central Board of secondary education New Delhi, then the recognition from the state Board and the grant from State Government would

cease automatically from the day it gets affiliated from the aforesaid board.

F. The teaching and the non-teaching staff of the Institute would not be provided pay scales and other allowances less than that is permissible to the employees of the Government aided educational Institutes.

G. Service rules would be framed for the employees deployed in the Institute and they would be provided with the retirement benefits permissible to the employees of the Government aided schools.

H. The Institute will comply to the orders issued by the state Government from time to time.

I. The record of the school would be maintained in prescribed formats and registers.

J. Without the prior approval of the Government, any change/amendment/ modification would not be done in the aforesaid conditions.

2. If it is found in the future that the inspection report/proposal is foully and is not as per the rules then the accountability/responsibility will be that of chief education officer, inspection officer and concerned institution.
3. Compliance of all rules and regulation regarding and use, provisions of construction work will be ensured by the said school. If the said institution is found to be in illegal possession of land, then the NOC will be withdrawn by State Government.
4. It is mandatory to ensure the safety of the children to follow the orders given by the honourable court and the government from time to time and should follow the provisions of RTE and RTI
5. School will follow the child protection act/juvenile act as per format 46 and the assessment of the exemption under the income tax section 12A.
6. The Institute will invariably submit U-Dise (unified District Information System in Education) forms duly filled every year in the concerned chief education officer's office.
7. It is mandatory for the institution to comply to the all restriction. If the restriction are not being followed by the institution and laxity of being followed in abiding than NOC will be withdrawn by the state government.
